

QUESTION BEGINS (A) WHETHER A NUMBER OF EMPLOYEES IN THE NORTHERN RAILWAYS HAVE BEEN WORKING OVER THERE FOR MORE THAN THE LAST TEN TO FIFTEEN YEARS; (B) THE DETAILS OF RULES WITH REGARD TO POSTINGS, TRANSFERS IN THE RAILWAYS; (C) THE NUMBER OF SUCH EMPLOYEES IN THE NORTHERN RAILWAYS AT PRESENT WHO HAVE NOT BEEN TRANSFERRED DURING THE LAST FIVE YEARS AS PER RULES ALONG WITH THE DETAILS OF THEIR NAMES AND POSTS; (D) THE NUMBER OF EMPLOYEES ASSOCIATED WITH VARIOUS UNIONS IN THE NORTHERN RAILWAYS WHO HAVE NOT BEEN TRANSFERRED FOR THE LAST FIVE TO SIX YEARS AND IF SO, THE DETAILS THEREOF ALONG WITH THEIR NAMES; (E) WHETHER THE GOVERNMENT PROPOSES TO TRANSFER THE SAID EMPLOYEES AS PER THE RULES; (F) IF SO, THE DETAILS THEREOF; AND (G) IF NOT, THE REASONS THEREFOR?
