ORDERS ISSUED ON RECOMMENDATIONS OF 7TH CPC 2.57 TIMES OF BP FOR IMMEDIATE FIXATION OF PENSION, COMMITTEE TO CONSIDER "FEASIBILITY" OF PARITY OF PENSION Banks to pay Revised Pension & disburse Arrears on or before 31st Aug.

Orders for implementation of the recommendations of 7th CPC, on 25th July for revision of Pay Structure of serving employees and on 4th August, 2016 for the Revision of Pensionary Benefits of Pre & Post 2016 Pensioners are issued. Following is the gist of the implementation orders on 7th CPC:

- i) Recommendations of 7th CPC will be implemented from 1-1-2016.
- ii) Present system of Pay Bands & Grade Pay has been replaced by Pay Levels & Pay Matrix.
- iii) Fitment factor of 2.57 will be applied to all Levels in the Pay Matrix for revision of pay & pension.
- iv) DA up to 125% as on 1-1-2016) will get subsumed with it. New DA will be paid from 1-7-2016.
- v) Rate of increment will be retained at 3 %.
- vi) Gratuity ceiling will be enhanced from Rs. 10 to 20 lakh.
- vii) Committee to consider feasibility of implantation of Parity of Pension of past & future Pensioners.
- viii) Committees to review Group Insurance Scheme, all Allowances & New Pension Scheme (NPS)
- ix) Committee to consider Anomalies arising out of implementation of 7th CPC's Report.
- x) Banks authorized to pay Revised Pension & disburse Arrears on or before 31st August, 2016.
- xi) No change in entitlement of Additional Pension/Family Pension at 80, 85, 90, 95 & 100 years of age.
- xii) Dearness Relief shall be given on Additional Pension/Family Pension.

PROTESTS & STRIKE BY CG EMPLOYEES WITHDRAWN AFTER ASSURANCE GIVEN BY GROUP OF MINISTERS TO FORM HIGH POWERED COMMITTEES TO REVIEW SOME RECOMMENDATIONS COMMITTEE YET TO BE FORMED TO REVIEW MINIMUM PAY & FIXATION FACTOR

Following wide spread protests by CG employees and their decision to go on Strike from 11th July, 2016, the Home Minister, Finance Minister and Railway Minister intervened and met the representatives of NJCA on June 30 and assured on behalf of the Government that the issues raised by them relating to Minimum Pay & Multiplication Formula would be re-considered by a High Powered Committee. But the High Powered Committee is yet to be formed even after more than a month causing serious apprehensions.

EMPANELMENT OF HOSPITALS & DIAGNOSTIC CENTRES BY NR IN TRICITY

Fulfilling a long pending demand of RSCWS, the GM Northern Railway has approved the empanelment of five Specialised Hospitals in and around Chandigarh for two years for cashless treatment of Railway Beneficiaries of Ambala Division both in referral cases as well as in case of Emergency. Empanelled Hospitals include FORTIS HOSPITAL PHASE 8 MOHALI, MAX HOSPITAL PHASE 6 MOHALI, INDUS HOSPITAL PHASE 1 MOHALI, GURU HARKRISHAN HOSPITAL SOHANA & IVY HOSPITAL SECTOR 70 MOHALI.

Five Diagnostic Canters have also been empanelled by Northern Railway – including PRIME DIAGNOSTIC CENTER, SUPERB MRI & CT SCAN CENTER SPIRAL CT SCAN & MRI CENTER, ATULYA HEALTH CARE & CHANDIGARH CLINICAL LAB.

COPY OF RESOLUTION OF GOI ON 7TH CPC REPORT ON PENSIONARY BENEFITS OF PRE-2016 PENSIONERS ISSUED VIDE DOP&PW ORDERS No.38/37/2016-P&PW (A) DATED 4TH AUGUST, 2016

1. Terms of Reference of the Seventh Central Pay Commission as contained in Ministry of Finance (Department of Expenditure) Resolution No.1/1/2013-E.III(A) dated 28.2.2014 included the following:

"To examine the principles which should govern the structure of pension and other retirement benefits, including revision of pension in the case of employees who have retired prior to the date of effect of these recommendations, keeping in view that retirement benefits of all Central Government employees appointed on and after 01.01.2004 are covered by the New Pension Scheme (NPS)."

- 2. The Commission, on 19th November, 2015, submitted its report to the Government on Terms of Reference as contained in aforementioned Resolution dated 28.02.2014. Government, after consideration, has decided to accept the recommendations of the Commission on pensionary benefits to the Central Government civil employees, including employees of the Union Territories and Members of All India Services subject to certain modifications, as specified hereinafter...
- 3. Detailed recommendations of the Commission relating to pensionary benefits and the decisions taken thereon by the Government are listed in the statement annexed to this Resolution.
- 4. The revised provisions regarding pensionary benefits, which have been accepted as indicated in the Annexure, will be effective from 01.01.2016.

Statement showing the recommendations of the Seventh Central Pay
Commission relating to principles which should govern the structure of pension
and other terminal benefits and the decisions of the Government thereon.

1. Fixed Medical Allowances

Recommendation: The Commission notes that this allowance was enhanced from Rs.300/-p.m. to Rs. 500/- p.m. from 19.11.2014. As such, further enhancement of this allowance is not recommended. (Para 8.17.52 of the Report)

<u>Decision of Government</u>: To be examined by a Committee comprising Finance Secretary and Secretary (Expenditure) as Chairman and Secretaries of Home Affairs, Defence, Posts, Health & Family Welfare, Personnel & Training and Chairman, Railway Board as Members. Till a final decision is taken based on the recommendations of the Committee, Fixed Medical Allowance shall be paid at existing rates.

2 Constant Attendance Allowance.

Recommendation: The allowance may be increased by a factor of 1.5 i.e. to Rs. 6750 per month. The allowance needs further increase by 25% each time DA rises by 50%. (Para 8.17.29 of the Report)

<u>Decision of Government</u>: To be examined by a Committee comprising Finance Secretary and Secretary (Expenditure) as Chairman and Secretaries of Home Affairs, Defence, Posts, Health & Family Welfare, Personnel & Training and Chairman, Railway Board as Members. Till a final decision is taken based on the recommendations of the Committee, Constant Attendant Allowance shall be paid at existing rates.

3 General Provident Fund

Recommendation: Status quo may be maintained in this respect. (Para 9.4.4 of the Report)

Decision of Government: Accepted

4 Rates of Pension & Family Pension

<u>Recommendation:</u> The Commission does not recommend any further increase in the rate of Pension and Family Pension from the existing levels. (Para 10.1.25 of the Report)

Decision of Government: Accepted

5 Quantum of Minimum Pension

Recommendation: The recommendations of the Commission in relation to pay of a personnel will lead to a significant increase in the minimum from the existing Rs.7,000 per month to Rs.18,000 per month. This, based on computation of pension, will raise minimum pension from the existing Rs.3500 to Rs.9000. The minimum pension based on the recommendations of the Commission will increase by 2.57 times over the existing level.

Decision of Government: Accepted

6 Rate of Additional Pension and Family Pension to the older pensioners

<u>Recommendation:</u> The Commission is of the view that the existing rates of additional pension and additional family pension are appropriate (20% at 80, 30% at 85, 40% at 90, 50% at 95 & 100% at 100 years of age).

Decision of Government: Recommendation Accepted

7 Time Period for enhanced family pension.

<u>Recommendation:</u> The Commission notes that the recommendation with regard to period of eligibility of the enhanced family pension of 10 years in case of death of a serving employee was made based on the recommendations of VIth CPC Report. No further change is being recommended by the Commission. (Para 10.1.33 of the Report)

Decision of Government: Recommendation Accepted

8 Gratuity ceiling and its indexation

Recommendation: The Commission recommends enhancement in the ceiling of gratuity from the existing Rs.10 lakh to Rs.20 lakh from 01.01.2016. The Commission further recommends the ceiling on gratuity may increase by 25% whenever DA rises by 50%.

Decision of Government: Recommendation Accepted

9 Rationalization of death gratuity (Para 10.1.41 of the Report)

Recommendation: Rationalization recommended at various stages

Decision of Government: Recommendation Accepted

10 Commutation of Pension and restoration of commuted pension

<u>Recommendation:</u> The Commission does not recommend any change either in the maximum percentage of commutation or in the period of restoration. (Para 10.1.43 of the Report)

Decision of Government: Recommendation Accepted

11 Revision of Pension of pre 7th CPC retirees

The Commission recommends the following pension formulation for civil employees including CAPF personnel who have retired before 01.01.2016

- (i) All the Civilian personnel including CAPF who retired prior to 01.01.2016 (expected date of implementation of the Seventh CPC recommendations) shall first be fixed in the Pay Matrix being recommended by this Commission, on the basis of the Pay Band and Grade Pay at which they retired, at the minimum of the corresponding level in the matrix. This amount shall be raised, to arrive at the notional pay of the retiree, by adding the number of increments he I she had earned in that level while in service, at the rate of three percent. Fifty percent of the total amount so arrived at shall be the revised pension.
- (ii) The second calculation to be carried out is as follows. The pension, as had been fixed at the time of implementation of the VI CPC recommendations, shall be multiplied by 2.57 to arrive at an alternate value for the revised pension.
- (iii) Pensioners be given the option of choosing whichever formulation is beneficial to them.
- It is recognized that the fixation of pension as per formulation in (i) above may take a little time since the records of each pensioner will have to be checked to ascertain the number of increments earned in the retiring level. It is therefore recommended that in the first instance the revised pension may be calculated as at (ii) above and the same may, be paid as an interim measure. In the event calculation as per (i) above yields a higher amount the difference may be paid subsequently.(Para 10.1.67 and Para 10.1.68 of the Report).

<u>Decision of Government</u> Both the options recommended by the 7th Central Pay Commission as regards pension revision be accepted subject to feasibility of theimplementation. Revision of pension using the second option based on fitment factor of 2.57 be implemented immediately. The first option may be made feasible after examination by the Committee comprising Secretary (Pension) as Chairman and Member (Staff). Railway Board, Member (Staff), Department of Posts, Additional Secretary & Financial Adviser, Ministry of Home Affairs and Controller General of Accounts as Members

12 Ex-gratia Lump sum Compensation (Para 10.2.77)

Recommendation: Enhancement of amount on Death on Duty Due to Accident, fighting with terrorists & on border & during war etc.

SMART CARD SCHEME FOR CASHLESS TREATMENT OF RELHS OPTEES RESTRICTED TO PENSIONERS OF FOUR METRO CITIES ONLY ON PAYMENT OF RS.10000 TO 50000

The much awaited Cashless Treatment Scheme in Emergency (CTSE) for Railway Pensioners & their Dependents, has been restricted to Pensioners in 4 Metro Cities and even the worst part of it is that the CTSE (Smart) Cards are to be issued on payment of Rs 10000 to 500000 as per Room entitlement for Cashless Treatment in any Empanelled Hospital in India.

Other RELHS Optees will continue to get coverage under the existing Scheme of RELHS-97. Copy of CTSE Policy letter dated 14-7-2016 of Railway Board & 5 Annexure thereof, have been placed on the RSCWS Website www.rscws.com. RSCWS SHALL BE STRONGLY REPRESENTING AGAINST THESE ORDERS.

RSCWS AGAIN URGES DRM AMBALA TO RESOLVE THE PROBLEMS OF PENSIONERS AT CHANDIGARH Copy of letter no. RSCWS/ HO / DRM/2016-6 Dated: 16-06-2016 to DRM N. Railway Ambala

Subject: Problems of Pensioners Reg. Issue of Revised PPOs, Smart Cards & Medical Problems

We draw your kind attention to the following problems of the Pensioners settled in and around Chandigarh, Panchkula & Mohali, and earnestly request you to redress the same:

1. ISSUE OF REVISED PPOS FOR REVISION OF PENSION OF PRE-2006 PENSIONERS:

Many of the Pre-2006 Pensioners of Ambala Division have not yet been issued Revised PPOs even after the lapse of considerable period of time since the issue of Railway Board's OMs dated 1-9-08, 11-2-13, 31-7-15 & 6-4-2016 cited above.

It is requested that the Revised PPOs be issued early to all Pre-2006 Pensioners – to avoid further hardship and loss to the old Pensioners especially before the onset of heavy rush of work due to implementation of 7th CPC Report.

2. ISSUE OF SMART CARDS TO RELHS OPTEES:

SMART CARDS have not yet been provided to the Pensioners for Cashless Service for RELHS Card Holder to take treatment in Recognized Private Hospitals in emergency, even though nearly four years have passed since the issue of orders for the same by the Railway Board vide letter No. 2007/H/28/1/RELHS/Smart Card dated 18.07.2012. This is causing much hardship to the Pensioners & their dependents and as such, needs to be expedited.

3. LACK OF MEDICAL SERVICES BY RAILWAYS FOR PENSIONERS AT CHANDIGARH:

There is absolute lack of Medical facilities for over 7000 Railway Beneficiaries - including nearly 1000 Pensioners and their dependents at Chandigarh, Panchkula & Mohali.

We have been earnestly requesting the Railway administration for ameliorating the suffering and hardship being faced by the old Pensioners. But it is regretted that the following problems are still left unresolved in spite of numerous representation to the Railway administration at various levels. This is causing much hardship to the patients - especially the old age Pensioners and their spouses – in spite of having served the Railways during long years of service and in spite of having paid for joining the RELHS-97 from their hard earned money.

Particular attention is invited to the following problems due to which all Railway Beneficiaries are seriously suffering – especially in their old age:

- i) Non filling up of either of the 2 Posts of Doctor at Chandigarh Health Unit.
- ii) Most Medicines are either NOT AVAILABLE or OUT OF STOCK most of the times.
- iii) Medicines prescribed by Specialists are not available and Procurement through CMS Ambala gets delayed.
- IV) 1 post of Pharmacist, 1 Dresser, 2 Attendants (One Male & one Female) are lying VACANT.
- V) Fan. Water Cooler with RO for the Patients has not been provided.
- Vi) 3 Rooms of Health Unit have been occupied by Dy. CE(Const)/CDG Office and others causing hindrance in the working of Health Unit and Dressing Room, Store Room or Toilet facilities have not been provided for Patients.
 - VII) Non implementations of Railway Board's Orders regarding the following:
 - a) Issue of Smart Cards to RELHS optees for Cashless treatment in empanelled Hospitals.
 - b) Empanelment of Specialised Private Hospitals including those empanelled under CGHS.
- Viii) Non empanelment of any Specialised Hospitals in or around Chandigarh creating major hardship to serious cases requiring specialized treatment.
 - X) No Diagnostic facilities are in NR Health Unit nor out-source Agency been Empanelled

It is, requested to provide the requisite facilities, so that the Health Unit at Chandigarh functions as per established norms and the Pensioners and other Railway Beneficiaries may get proper Medical Treatment.





CONDITIONS FOR GETING CASHLESS TREATMENT IN ABOVE SAID EMPANNELLED HOSPITALS

- 1. Railway Medical Card / RELHS Card in all cases
- 2. Referal Cases: Authorisation letter from CMS In-charge Railway Hospital Ambala Cantt.
- 3. In case of "Emergency" * immediate treatment will be provided by the Empanned Hospital, CMS Ambala shall be informed immediately by FAX by the Hospital Authorisation letter from CMS shall be issued within 24 hours thereof.

"Emergency" shall mean:- Any Conditions or Symptom resulting from any cause arising suddenly and if not treated at the early Convenience be detrimental to the health of the patient or will jeopardise the life of the patient.

In emergency the empanelled Hospital will not refuse admission or demand an advance from the Railway beneficiary or his family members and will provide credit facilities to the patient whether the patient is a serving employee or a pensioner, on production of a Railway Medical Card and the Hospital shall submit the bill for reimbursement to the concerned Railway authorities. The refusal to provide treatment to the bonafide Railway beneficiaries on credit basis, without valid ground would attract disqualification for continuation of empanelment.

The following ailments may be treated as emergency which is illustrative only and not exhaustive, depending on the condition of the patient:

- i) Acute Coronary Syndromes (*Heart Attack*) (Coronary Artery Bye-pass Graft/Percutaneous, Tran luminal Coronary Angioplasty) including Myocardial Infarction, Unstable Angina, Ventricular Arrhythmias, Paroxysmal Supra
- ii) Ventricular Tachycardia, Cardiac Temponade, Acute Left Ventricular Failure / Severe Congestive Cardiac Failure, Accelerated Hypertension, Complete Heart Block and Stoke Adam attack, Acute Aortic Dissection.
- iii) Acute Limb Ischemia, Rupture of Aneurysm, Medical and Surgical shock and peripheral circulatory failure. Cerebro-Vascular attack-Stokes, Sudden unconsciousness, Head injury, Respiratory failure, decompensated lung disease, Cerebro-Meningeal Infections, Convulsions, Acute Paralysis, Acute Visual loss.
- iv) Acute Abdomen pain.
- v) Road Traffic Accidents / with injuries including fall. Severe Hemorrhage due to any cause.
- vi) Acute poisoning. -Acute Renal Failure.
- vii) Acute abdomen pain in female including acute Obstetrical and Gynecological emergencies.
- viii) Electric shock.
- ix) Any other life threatening condition.
