

Ministry of Railways (Railway Board) have decided to constitute a Committee to examine and tender their recommendations, so as to bring all Railway Employees under the Medical Insurance Scheme, for obtaining treatment in Private Hospitals and other related matters.

2. The Terms of Reference of the Committee shall be as under:-


- (i) To examine and recommend the scope of In-Patient Treatment, Out-Patient Treatment and Medical Coverage to be obtained from the Insurance Company/Private Hospital and the Service Agreement to be executed with them.
- (ii) To consider the views/suggestions received from Zonal Railways/Production Units and the Federations in the aforesaid matter, and
- (iii) To delve any other issue considered relevant or that may come up before the Committee, during its deliberations.

3. The tenure of the Committee shall be one month from the date of its constitution.

4. The Headquarters of the Committee will be at New Delhi.

5. **E(W) branch**, Railway Board will coordinate the work relating to functioning of the Committee and submission of the report. However, after submission of the report of the Committee, implementation of its recommendations and all related issues including Parl. Questions, RTI cases and other related matters shall be dealt with by **Health Branch**, Railway Board.

6. The Convener and Members of the Committee will draw TA/DA as per extant rules.
