Subject: **REMINDER REGARDING: - ACTION PROGRAMME IRTSA – 2012**

Reference: This office circular of even number dated 9-6-2012.

1. As mentioned in my circular dated 9-6-2012, many of our demands are still pending since long in spite numerous representations – including the following:

- i) SSE, CMS & CDMS continue to suffer extreme stagnation. Many SSE & CMS have been rotting in the same grade for 15 to 20 years or more and may retire in the same grade.
- ii) Directly recruited Engineering Degree Holder SSEs - are still worst off without a single promotion.
- iii) CMA I have not yet been given the Pre-revised scale of Rs.7450-11500 as per Sixth CPC
- iv) Demand for higher grade pay to Senior Supervisors has not been accepted.
- v) Orders reg. Classification of Posts of Senior Supervisors in Group B have not been implemented on the Railways
- vi) Many other demands are also hanging fire for the last many years with no redressal, in spite of repeated representations & and assurances by the administration .

2) a) **LINE OF ACTION:** In view of the above facts Central President IRTSA - in consultation with the General Secretary IRTSA - has decided that the following Action Programme be observed by all Units of IRTSA and Rail Engineers at large - for effective pursuance of the Main Demands.

2. b) All units and subunits of IRTSA are, therefore, requested to observe the following programme effectively :


